# The Initial Value Problem for Cubic Semilinear Schrödinger Equations

# Abstract

We present local and global existence theorems for cubic semilinear Schrödinger equations. Our new results are the improvement of our previous ones ([2], [3], [4]). The idea of the proof consists of the energy and the decay estimates. These equations do not allow the classical energy estimates. To avoid this difficulty, we make strong use of S. Doi's method for linear Schrödinger type equations. Combining cubic nonlinearity and S. Doi's method, we obtain the improved results.

# **§1.** Introduction

This paper is concerned with the initial value problem for semilinear Schrödinger equations of the form

$$\partial_t u - i \Delta u = F(u, \nabla u) \quad \text{in } (0, \infty) \times \mathbf{R}^N,$$
 (1.1)

$$u(0, x) = u_0(x) \qquad \text{in} \quad \mathbf{R}^N, \tag{1.2}$$

where u(t, x) is **C**-valued,  $i = \sqrt{-1}$ ,  $\partial_t = \partial/\partial t$ ,  $\partial_j = \partial/\partial x_j$ ,  $j = 1, \dots, N$ ,  $\nabla = (\partial_1, \dots, \partial_N)$ ,  $\Delta = \partial_1^2 + \dots + \partial_N^2$  and  $N \in \mathbf{N}$  is the space dimension. We assume that the nonlinear term  $F(u, q) \in C^{\infty}(\mathbf{R}^2 \times \mathbf{R}^{2N}; \mathbf{C})$  satisfies

$$|F(u, q)| \le C(|u|^p + |q|^p)$$
 near  $(u, q) = 0$ ,

with some integer  $p \ge 2$ , where  $q \in \mathbb{C}^N$  corresponds to  $\nabla u$ . Throughout this paper we use the following notations.

for  $s, s' \in \mathbb{R}$ .  $\|\cdot\|_s$  means  $(H^s)^2$ -norm. Especially  $\|\cdot\|$  and  $(\cdot, \cdot)$  mean  $(L^2)^2$ -norm and  $(L^2)^2$ -inner product respectively.  $\mathscr{B} = \mathscr{B}(\mathbb{R}^N)$  and  $\mathscr{B}' = \mathscr{B}'(\mathbb{R}^N)$  denote the Schwartz class and its topological dual space respectively.  $\mathscr{B}^{\infty} = \mathscr{B}^{\infty}(\mathbb{R}^N)$  is the set of all  $C^{\infty}$ -functions on  $\mathbb{R}^N$  whose derivatives of any order are all bounded. When X and Y are normed vector spaces,  $\mathscr{L}(X, Y)$  and  $\mathscr{L}(X)$  are the set of all bounded linear operators of X to Y and of X to X respectively.  $\check{x}_j = (x_1, \dots, x_{j-1}, x_{j+1}, \dots, x_N)$ , for  $x \in \mathbb{R}^N$  and  $j=1, \dots, N$ .  $\delta_{jk}$  is Kronecker's delta, i.e.,  $\delta_{jk}=1$  if j $= k, \ \delta_{jk} = 0$  otherwise. [s] means the largest integer less than or equal to  $s \ge 0$ . Different positive constants might be denoted by the same letter C.

In this problem the difficulty of so-called loss of derivatives takes place because the nonlinear term  $F(u, \nabla u)$  contains  $\nabla u$ . More precisely, if SEMILINEAR SCHRODINGER EQUATIONS

$$\operatorname{Im} \frac{\partial F}{\partial q_j}(u, q) \equiv 0, \qquad j = 1, \cdots, N, \qquad (1.3)$$

then one can obtain the classical energy estimates for the solution u. In general the classical energy estimates do not hold without (1.3). Then studies on the initial value problem (1.1) - (1.2) have been mainly concerned with the case of (1.3). Recently, however, several researchers have been studying (1.1) - (1.2) without the condition (1.3) ([1],[2],[3],[4],[7],[8],[10],[11],[18],[20]). Except for [11], these works are the application of the theory of linear Schrödinger type equations (see S. Mizohata [14, Lecture VII] and S. Doi [5] for instance). Especially S. Doi's method is effective for the application to semilinear equations. In fact, using his method, the author studied the local and the global existence for general semilinear equations which do not satisfy (1.3) (see [2], [3] and [4]). On the other hand, C. E. Kenig-G. Ponce-L. Vega ([11]) obtained the sharp version of the smoothing property of  $e^{it\Delta}$  and applied it to the local existence of small solutions to the general semilinear equations.

The purpose of this paper is to improve the results in [2], [3] and [4]. If the nonlinear term F(u, q) is cubic  $(p \ge 3)$ , then the Taylor formula gives

$$F(u, q) = F_3(u, q) + F_4(u, q)$$
 near  $(u, q) = 0$ ,

where  $F_3(u, q)$  is a cubic homogeneous polynominal of u,  $\bar{u}$ , q,  $\bar{q}$  and  $F_4(u, q)$  is a higher order term. We shall prove

**Theorem 1.1.** We assume  $N \ge 2$  and  $p \ge 3$ . Then there exists a sufficiently large integer  $m_1 \in \mathbb{N}$  such that for any  $u_0 \in H^m$   $(m \ge m_1)$ , there exists a time  $T = T(\|u_0\|_{H^{m_1}}) > 0$  such that the initial value problem (1.1) - (1.2) rossesses a unique solution  $u \in C([0, T); H^m)$ .

**Theorem 1.2.** We assume  $N \ge 3$  and  $p \ge 3$ . Then there exist sufficiently large integer  $m_2 \in \mathbb{N}$  and a small constant  $\delta > 0$  such that for any

$$u_0 \in \bigcap_{j=0}^{2} H^{m-2j,j} \ (m \ge m_2 + 2) \ satisfying \sum_{j=0}^{2} ||u_0||_{H^{m_2-2j,j}} \le \delta$$

the initial value problem (1.1) - (1.2) possesses a unique solution

$$u \in \bigcap_{j=0}^{2} C([0,\infty); H^{m-2j,j}).$$

and

**Theorem 1.3.** We assume N = 2,  $p \ge 3$  and  $F_3(u, q)$  satisfies the gauge invariance

$$F_3(e^{i\theta}u, e^{i\theta}q) = e^{i\theta}F_3(u, q) \quad for \quad (u, q) \in \mathbb{C} \times \mathbb{C}^N, \quad \theta \in \mathbb{R}.$$
(1.4)

Then there exist a sufficiently large integer  $m_3 \in \mathbb{N}$  and a small constant  $\delta > 0$  such that for any

$$u_0 \in \bigcap_{j=0}^{1} H^{m-2j,j} \quad (m \ge m_3 + 2) \text{ satisfying } \sum_{j=0}^{1} ||u_0||_{H^{m_3-2j,j}} \le \delta,$$

the initial value problem (1, 1) - (1, 2) possesses a unique solution

$$u \in \bigcap_{j=0}^{1} C([0, \infty); H^{m-2j,j}).$$

*Remark* 1.1. Because we use pseudo-differential operators, it is troublesome to determine the minimum value of  $m_1$ ,  $m_2$  and  $m_3$ .

Remark 1.2. In [2] the author proved the similar results for the case of  $p \ge 2$ . There we made use of the weighted Sobolev space  $H^m \cap H^{m-1,1}$  for  $p \ge 3$  or  $H^m \cap H^{m-2,2}$  for  $p \ge 2$ . Hence Theorem 1.1 is an improvement of [2] in the case of  $p \ge 3$ .

*Remark* 1.3. In [3] and [4] the author studied the global existence for general semilinear equations: if we assume

$$N(p-1)^{2}/2p > \begin{cases} 2, p \ge 3\\ 3, p=2 \end{cases}$$

or if we assume the gauge invariance

$$F(e^{i\theta}u, e^{i\theta}q) = e^{i\theta}F(u, q) \quad \text{for} \quad (u, q) \in \mathbb{C} \times \mathbb{C}^{N}, \quad \theta \in \mathbb{R},$$
(1.5)

and N(p-1) / 2 > 2, then the global existence results hold. Clearly Theorems 1.2 and 1.3 are improvement of [3] and [4]. This is basically due to the device for how to apply S. Doi's method to semilinear equations. Unfortunately this device is not applicable to quadratic nonlinearity. We explain the detail at

the end of  $\S 2$  (Remark 2.1).

Now we give the strategy of the proof. Theorem 1.1 is proved by the parabolic regularization and the uniform estimates which follow from the energy estimates. Theorems 1.2 and 1.3 are proved by Theorem 1.1 and *a priori* estimates which consists of the energy and the decay estimates.

For the energy estimates, we see the equation (1.1) as a system of  $(u, \bar{u})$  because the nonlinear term  $F(u, \nabla u)$  contains not only  $\nabla u$  but also  $\nabla \bar{u}$ . After the diagonalization of this system modulo bounded operators, this system becomes a couple of single Schrödinger type equation essentially. Then we can use S. Doi's method and obtain the energy inequality.

On the other hand, we get the decay estimates by the operator J and the Gagliardo-Nirenberg inequality (see Lemma 3.1). It is well-known that this technique is effective for the case of (1.5) because J acts on the nonlinear term  $F(u, \nabla u)$  satisfying (1.5) as if it were the usual differentiation  $\partial$ . Conversely J does not act well without (1.5): the more we use J, the more the loss of decay becomes. N. Hayashi ([6]) made good use of J for some quadratic nonlinear term satisfying (1.3) and obtained some extension of [13] and [19]. We also use the similar technique to that of [6].

The organization of this paper is as follows. §2 consists of the linear estimates for some Schrödinger type systems. §3 contains preliminary results. In §4, §5 and §6 we prove Theorems 1.1, 1.2 and 1.3 respectively.

## §2. Linear Estimates

In this section we study the initial value problem for the following linear Schrödinger type systems

$$Lv \equiv (I\partial_t + iH(t)) v = f(t, x) \qquad \text{in} \quad (0, T) \times \mathbb{R}^N, \qquad (2.1)$$

$$v(0, x) = v_0(x) \qquad \text{in } \mathbf{R}^N, \qquad (2.2)$$

where v = v(t, x) is C<sup>2</sup>-valued, I is the 2 × 2 identity matrix and the operator H(t) = h(t, x, D) is defined by

$$h(t, x, \xi) = a(\xi) + b(t, x, \xi), \qquad a(\xi) = \begin{bmatrix} |\xi|^2 & 0\\ 0 & -|\xi|^2 \end{bmatrix},$$
  
$$b(t, x, \xi) = \begin{bmatrix} b_{11}(t, x, \xi) & b_{12}(t, x, \xi)\\ b_{21}(t, x, \xi) & b_{22}(t, x, \xi) \end{bmatrix} = \sum_{j=1}^{N} \begin{bmatrix} b_{11j}(t, x) & b_{12j}(t, x)\\ b_{21j}(t, x) & b_{22j}(t, x) \end{bmatrix} \xi_{j},$$
  
$$b_{mnj}(t, x) \in C^{1}([0, T]; \mathscr{B}^{\infty}), \quad m, n = 1, 2 \text{ and } j = 1, \cdots, N.$$

For the convenience, we put

$$b^{\text{diag}}(t, x, \xi) \begin{bmatrix} b_{11}(t, x, \xi) & 0\\ 0 & b_{22}(t, x, \xi) \end{bmatrix}, \quad b^{\text{off}}(t, x, \xi) = \begin{bmatrix} 0 & b_{12}(t, x, \xi)\\ b_{21}(t, x, \xi) & 0 \end{bmatrix}.$$

When we apply the linear estimates in this section to (1.1) - (1.2), we see v as  $v = {}^{t}(u, \bar{u})$ . For  $H^{s}$ -wellposedness of (2.1) - (2.2), we assume the Doi type condition on  $b^{\text{diag}}(t, x, \xi)$ , that is to say, there exist functions

$$\phi_j(t, s) \in C([0, T]; \mathscr{B}^{\infty}(\mathbb{R})) \cap C^1([0, T]; L^1(\mathbb{R})), \qquad j=1, \dots, N$$

such that

$$|\operatorname{Im} b_{nnj}(t, x)| \le \phi_j(t, x_j)$$
 for  $(t, x) \in [0, T] \times \mathbb{R}^N$ ,  $n=1, 2, j=1, \cdots, N$ .  
(2.3)

Our analysis is based on the symbolic calculus for pseudo-differential operators (see [9] or [14] for instance).

For  $H^{s}$ -wellposedness we have

**Proposition 2.1.** We assume (2.3). Then the initial value problem (2.1) – (2.2) is  $H^s$ -wellposed for any  $s \in \mathbb{R}$ , that is to say, for any  $v_0(x) \in (H^s)^2$  and for any  $f(t, x) \in (L^1_{loc}(0, T; H^s))^2$ , (2.1) – (2.2) possesses a unique solution  $v \in (C([0, T]; H^s))^2$ .

We have only prove Proposition 2.2 with s=0. Our strategy divides into two steps. At the first step we diagonalize the operator H(t) modulo bounded operators. Roughly speaking, its symbol

$$h(t, x, \xi) = \begin{bmatrix} |\xi|^2 + b_{11}(t, x, \xi) & b_{12}(t, x, \xi) \\ b_{21}(t, x, \xi) & -|\xi|^2 + b_{22}(t, x, \xi) \end{bmatrix}$$

has two distinct eigen-values provided that  $|\xi|$  is sufficiently large. Thus we can easily diagonalize  $h(t, x, \xi)$  and therefore this system becomes a couple of single Schrödinger type equations essentially. At the second step we apply S. Doi's method ([5]) to the diagonalized system.

Following [2] or [3], we explain the outline of proof of Proposition 2.2. We introduce some pseudo-differential operators for this purpose. The diagonalization is carried out by

$$\begin{split} \Lambda(t) &= I + \tilde{\Lambda}(t), \qquad \Lambda'(t) = I - \tilde{\Lambda}(t), \qquad \tilde{\Lambda}(t) = \tilde{\lambda}(t, x, D), \\ \tilde{\lambda}(t, x, \xi) &= \frac{1}{2} \sum_{j=1}^{N} \begin{bmatrix} 0 & b_{12}(t, x) \\ - b_{21j}(t, x) & 0 \end{bmatrix} \xi_{j} \langle \xi \rangle^{-2}. \end{split}$$

The loss of derivatives is resolved by

$$\begin{split} K(t) &= k(t, x, D), & K'(t) = k'(t, x, D), \\ k(t, x, \xi) &= \begin{bmatrix} k_1(t, x, \xi) & 0\\ 0 & k_1'(t, x, \xi) \end{bmatrix}, & k'(t, x, \xi) = \begin{bmatrix} k_1'(t, x, \xi) & 0\\ 0 & k_1(t, x, \xi) \end{bmatrix}, \\ k_1(t, x, \xi) &= \exp\left(-p(t, x, \xi)\right), & k_1'(t, x, \xi) = \exp\left(p(t, x, \xi)\right), \\ p(t, x, \xi) &= \sum_{j=1}^N \int_0^{x_j} \phi_j(t, s) \, ds \xi_j \langle \xi_j \rangle^{-1}. \end{split}$$

It is convenient to use the following notations

$$B_{K}(t) = \sup_{(x,\xi)\in\mathbf{R}^{N}\times\mathbf{R}^{N}} \sum_{|\alpha+\beta|\leq l} |\partial_{\xi}^{\alpha}D^{\beta}k_{1}(t, x, \xi)| + \sup_{(x,\xi)\in\mathbf{R}^{N}\times\mathbf{R}^{N}} \sum_{|\alpha+\beta|\leq l} |\partial_{\xi}^{\alpha}D^{\beta}k_{1}(t, x, \xi)^{-1}|,$$
  

$$B_{b}(t) = \sum_{m,n=1,2} \sum_{j=1}^{N} \sum_{|\alpha|\leq l} \left( \sup_{x\in\mathbf{R}^{N}} |\partial^{\alpha}b_{mnj}(t, x)| + \sup_{x\in\mathbf{R}^{N}} |\partial_{t}\partial^{\alpha}b_{mnj}(t, x)| \right)$$
  

$$B_{\phi}^{0}(t) = \sum_{j=1}^{N} \int_{-\infty}^{+\infty} \phi_{j}(t, x_{j}) dx_{j}, \qquad B_{\phi}^{1}(t) = \sum_{j=1}^{N} \sup_{x_{j}\in\mathbf{R}} \left| \int_{0}^{x_{j}} \partial_{t}\phi_{j}(t, y_{j}) dy_{j} \right|,$$
  

$$B_{\phi}^{\infty}(t) = \sum_{j=1}^{N} \sum_{k=0}^{l} \sup_{x_{j}\in\mathbf{R}} |\partial_{j}^{k}\phi_{j}(t, x_{j})|$$

where  $l \in \mathbf{N}$  is large enough to be used in this section. It is very troublesome to find the minimum value of l.  $m_1$ ,  $m_2$  and  $m_3$  in §1 is determined by N and l (see Remark 1.1). To eliminate the loss of derivatives in (2.1), we use the map  $v \mapsto K(t) \Lambda(t) v$ . Before we use this map, we verify that this is automorphic on  $(L)^2$  in some sense.

**Lemma 2.2.** There exists a constant C > 0 such that

$$\|v\| \le CB_{K}(t) (1 + B_{b}(t))^{2} (1 + B_{\phi}^{0}(t) B_{\phi}^{\infty}(t)) N_{t}(v), \qquad (2.4)$$

$$N_t(v) \le CB_K(t) \left(1 + B_b(t)\right) \|v\|$$
(2.5)

for  $v \in (L^2)^2$  and  $t \in [0, T]$ , where  $N_t(v) = ||K(t)\Lambda(t)v|| + ||v||_{-1}$ .

*Proof.* See [2] or [3]. □

Using K(t), K'(t),  $\Lambda(t)$  and  $\Lambda'(t)$ , we get

$$K(t)\Lambda(t)Lv = (I\partial_t + ia(D) + q(t, x, D))K(t)\Lambda(t)v + R_1(t)v,$$
(2.6)

$$\begin{split} q(t, x, \xi) &= 2I \sum_{j=1}^{N} \phi_{j}(t, x_{j}) \,\xi_{j} \langle \xi_{j} \rangle^{-1} + i b^{\operatorname{diag}}(t, x, \xi) \\ &= \sum_{j=1}^{N} \begin{bmatrix} 2\phi_{j}(t, x_{j}) \,\xi_{j} \langle \xi_{j} \rangle^{-1} + i b_{11j}(t, x) \,\xi_{j} & 0 \\ 0 & 2\phi_{j}(t, x_{j}) \,\xi_{j} \langle \xi_{j} \rangle^{-1} + i b_{22j}(t, x) \,\xi_{j} \end{bmatrix}, \end{split}$$

where  $R_1(t)$  is a bounded operator which is estimated as

$$\|R_{10}(t)\|\mathscr{L}((L^2)^2) \le C(B_b(t) + B^1_{\phi}(t) + B^{\infty}_{\phi}(t)) (1 + B^{\infty}_{\phi}(t)) (1 + B_b(t))^3 B_K(t).$$
(2.7)

To complete the proof of Proposition 2.2, we tave only to show the following energy inequalities. More precisely, Proposition 2.2 follows from the duality type arguments for the forward and the backward initial value problems. The energy inequalities play an essential role in these arguments. See L. Hörmander [9, section 23.1] for the detail.

**Lemma 2.3.** There exists a constant  $C_T > 0$  such that

$$\|v(t)\| \le C_T \Big( \|v(0)\| + \int_0^t \|(Lv)(\tau)\| d\tau \Big),$$
(2.8)

$$\|v(t)\| \le C_T \Big( \|v(T)\| + \int_t^T \|(L^*v)(\tau)\| d\tau \Big),$$
(2.9)

for  $v \in (C([0, T]; H^2) \cap C^1([0, T]; L^2)^2, t \in [0, T].$ 

Here  $L^*$  is the formally adjoint operator of L.

*Proof.* We put  $w = K(t)\Lambda(t)v$ , f(t, x) = (Lv)(t, x) and  $g = K(t)\Lambda(t)f$ . Applying (2.3) and the sharp Gårding inequality to (2.6), we get

$$\frac{d}{dt} \|w(t)\| \le C(B_b(t) + B^1_{\phi}(t) + B^{\infty}_{\phi}(t)) B_{\text{etc}}(t) N_t(v(t)) + \|g(t)\|, \quad (2.10)$$
$$B_{\text{etc}}(t) = (1 + B_b(t))^5 (1 + B^0_{\phi}(t)) (1 + B^{\infty}_{\phi}(t))^2 B_K(t)^2.$$

On the other hand, we have

Combining (2.10) and (2.11), we obtain

$$\frac{d}{dt}N_t(v(t)) \le C(B_b(t) + B_{\phi}^1(t) + B_{\phi}^{\infty}(t)) \ B_{\text{etc}}(t) N_t(v(t)) + N_t(f(t)).$$

(2.4), (2.5) and (2.12) implies (2.8). In the same way we can get (2.9). This completes the proof of Lemma 2.3 and then we finish the proof of Proposition 2.1.  $\Box$ 

*Remark* 2.1. When we apply Proposition 2.1 or Lemma 2.3 to (1.1) - (1.2), we take  $\phi_j(t, x_j)$  satisfying

$$\sup_{\tilde{x}, \in \mathbf{R}^{N-1}} \left| \frac{\partial F}{\partial q_j}(u, \nabla u)(t, x) \right| \leq \phi_j(t, x_j), \quad j=1, \cdots, N.$$

Then we choose  $\phi_j(t, x_j)$  as

$$\phi_j(t, x_j) = M \int_{\mathbf{R}^{N-1}} |\langle D \rangle^{[(N-1)/2]+2} u(t, x)|^2 d\tilde{x}_j$$

with some constants M > 0 and d > 0. On the other hand, in [2], [3] and [4] we chose  $\phi_j(t, x_j)$  as

$$\phi_j(t, x_j) = \phi(x_j) = M \langle x_j \rangle^{-1-\delta}$$
(2.16)

or

$$\phi_j(t, x_j) = M(1+t)^{-d} \langle x_j \rangle^{-1-\delta}$$
(2.17)

with some constants M>0,  $\delta>0$  and d>0. (2.14) or (2.16) is applied to the local existence. To use (2.16), we need the spatial decay of the solution and then we have to introduce the weighted Sobolev spaces. On the other hand, we make use of (2.15) or (2.17) to obtain the global existence results. (2.17) causes generally loss of time-decay and (2.15) does not. (2.15) has the structural nice pro-

perty. In [10] S. Katayama Y. Tsutsumi made good use of this property to study the global existence theorem for (1.1) - (1.2) in one space dimension (N=1). In the present paper this is not essential necessarily. It is more important that  $\phi_j(t,\cdot)$  is smooth enough to be treated by the symbolic calculus. Unfortunately, when F(u, q) is quadratic, (2.14) and (2.15) are not applicable to (1.1) - (1.2). It seems to be difficult to find sufficiently smooth functions  $\phi_j(t, x_j)$ , j=1,  $\cdots$ , N, which give no loss of time-decay and are applicable to the quadratic non-linearity.

# §3. Preliminaries

This section is devoted to the estimates on the nonlinear term  $F(u, \nabla u)$ . Here the Gagliardo-Nirenberg inequality plays an important role.

#### Lemma 3.1. (The Gagliardo-Nirenberg inequality)

Let  $r_0$ ,  $r_1$ , and  $r_2$  satisfy  $1 \le r_0$ ,  $r_1$ ,  $r_2 \le \infty$ , and let  $j_1$  and  $j_2$  be integers satisfying  $0 \le j_1 < j_2$ . Then there exists a constant  $C_0 = C_0(N, j_1, j_2, r_0, r_2, a) > 0$  such that for any  $u \in L^{r_0}$  satisfying  $\partial^{\alpha} u \in L^{r_2}$ ,  $|\alpha| = j_2$ , the following inequalities hold

$$\sum_{|\beta|=j_1} \|\partial^{\beta} u\|_{L^{r_1}} \leq C_0 \sum_{|\alpha|=j_2} \|\partial^{\alpha} u\|_{L^{r_2}}^{\alpha} \|u\|_{L^{r_0}}^{1-a}$$
(3.1)

where

$$\frac{1}{r_1} = \frac{j_1}{N} + a \left( \frac{1}{r_2} - \frac{j_2}{N} \right) + (1 - a) \frac{1}{r_0}$$

for all a in the interval

$$\frac{j_1}{j_2} \le a \le 1,$$

with the following exceptional cases

i) If  $j_1=0$ ,  $r_2j_2 < N$ ,  $r_0=\infty$ , then we make the additional assumption that  $u(x) \rightarrow 0$  as  $|x| \rightarrow +\infty$ . ii) If  $1 < r_2 < \infty$ , and  $j_2 - j_1 - N/r_2 \in \mathbb{Z}_+$ , then (3.1) holds only for a satisfying  $j_1/j_2 \le a \le 1$ .

*Proof.* See L. Nirenberg [17] for instance.

To prove Theorem 1.1 we prepare

**Lemma 3.2.** We assume  $F(u, q) \in C^{\infty}(\mathbb{R}^2 \times \mathbb{R}^{2N}; \mathbb{C})$  and F(0, 0) = 0. Let m be an integer > N/2+1. Then there exists a non-decreasing function  $A_m(\cdot)$  on  $[0, \infty)$  such that for any  $u, v \in H^m$ ,

$$\|F(u, \nabla u)\|_{H^{m-1}} \le A_m(\|u\|_{W^{1,\infty}}) \|u\|_{H^m}, \qquad (3.2)$$

$$P(u, \nabla u, \partial \partial^{\alpha} u) = \sum_{j=1}^{N} \frac{\partial F}{\partial q_{j}}(u, \nabla u) \partial_{j} \partial^{\alpha} u + \sum_{j=1}^{N} \frac{\partial F}{\partial \bar{q}_{j}}(u, \nabla u) \partial_{j} \partial^{\alpha} \bar{u}.$$

*Proof.* Making good use of the Gagliardo-Nirenberg inequality we can show Lemma 3.2. This is basically due to J. Morser ([16]) (see also S. Klainerman[12]).  $\Box$ 

Now we prepare to obtain the estimates on the nonlinear term in order to prove the global existence theorem. Especially we get the decay estimates by the operator J and the Gagliardo-Nirenberg inequality. Here we note the properties of J:

$$[J_k, \partial_t - i\Delta] = [J_k, J_l] = 0, \ [\partial_k, J_l] = \delta_{kl}, \quad k, \ l = 1, \ \cdots, \ N.$$

To get the decay estimates we prepare

# Lemma 3.3.

(1) Let N=1. For any  $u \in H^1 \cap H^{0,1}$ ,

$$\sum_{|\beta'|=1} \|J^{\beta'}w\|_{L^{\infty}} \le C(1+t)^{-1} \sum_{\substack{|\alpha| \le 1\\|\beta|=2}} \|\partial^{\alpha}J^{\beta}w\|_{L^{2}}.$$

*Proof.* Let  $\theta = \theta(t, x) = \theta(t, x_1) + \dots + \theta(t, x_N) = |x|^2/4(1+t)$ .

$$\sum_{\substack{|\beta|=1\\|\beta|=1}} \|J^{\beta}v\|_{L^{4}} \leq \sum_{\substack{|\alpha|=1\\|\beta|=1}} \|\partial^{\alpha}J^{\beta}v\|_{L^{2}}^{1/2} \sum_{\substack{|\beta'|=1\\|\beta'|=1}} \|J^{\beta'}v\|_{L^{2}}^{1/2},$$

Combining  $(3.9) \sim (3.11)$  we obtain (3.6).

For (3.7), by (3.1) with N=3,  $r_0=6$ ,  $r_1=\infty$ ,  $r_2=6$ ,  $j_1=0$ ,  $j_2=1$  and a=1/2 we have

We use the abridged notations of the nonlinear terms, i.e., we abbreviate  $F(u(t), \nabla u(t))$  as F(t) for instance. The properties of the nonlinear term  $F(u, \nabla u)$  are the following.

$$\begin{split} \partial^{\alpha} J^{\beta} F - P_{\alpha\beta} &= (\partial^{\alpha} P_{0\beta} - P_{\alpha\beta}) \\ &+ \sum_{|\alpha'|=m-4} (\partial^{\alpha'} Q_{1\alpha'} + (1+t) \,\partial^{\alpha'} C_{2\alpha'} + (1+t)^2 \partial^{\alpha'} C_{1\alpha'}). \end{split}$$

The structures of  $Q_{1\alpha'}$ ,  $Q_{2\alpha'}$  and  $C_{1\alpha'}$  are the same as those of  $Q_1$ ,  $Q_2$  and  $C_1$  respectively, and  $Q_{1\alpha'}$  does not contain  $\nabla J^2 u$ . Then we obtain

$$\sum_{\substack{|\alpha|=m-4\\|\beta|=2}} \|(\partial^{\alpha}J^{\beta}F - P_{\alpha\beta})(t)\|_{L^{2}} \le C(1+t)^{-3/4}X_{m}^{N}(t)^{3}.$$
(3.25)

(3.24) - (3.25) shows (3.19).

Now we consider the part (2). In the same way as (3.17) we can show (3.20) with (3.12) and (3.13). But there are some differences between the proofs of (3.18) and of (3.21). First we remark that because  $F_3(u, q)$  satisfies (1.4), the loss of decay does not take place in  $F_3(u, \nabla u)$ . In fact we have

$$JF_{3}(u, \nabla u) = \frac{\partial F_{3}}{\partial u}(u, \nabla u) Ju - \frac{\partial F_{3}}{\partial \bar{u}}(u, \nabla u) \overline{Ju} + \sum_{j=1}^{N} \frac{\partial F_{3}}{\partial q_{j}}(u, \nabla u) J\partial_{j}u - \sum_{j=1}^{N} \frac{\partial F_{3}}{\partial \bar{q}_{j}}(u, \nabla u) \overline{J\partial_{j}u}$$

Then the simple calculation gives

$$JF = Q_3(u, \nabla u, Ju, \nabla Ju) + (1+t) C_3(u, \nabla u, \nabla^2 u),$$
  

$$Q_3 = Q_4(u, \nabla u) \times (u, \nabla u, Ju, \nabla Ju),$$
  

$$Q_4 = \text{quadratic term of } (u, \nabla u),$$
  

$$C_3 = \text{the fourth order term of } (u, \nabla u, \nabla^2 u).$$

In the same way as the evaluation to  $C_0(t)$  we can estimate  $C_3(t)$ . On the other hand, if we try to get the bound of  $Q_3(t)$  by the same technique used for  $Q_0(t)$ , then the lack of decay occurs. To avoid this difficulty we make use of another estimates. We have

$$\| Q_3(t) \|_{H^2} \le C \| Q_4(t) \|_{W^{2,\infty}} (\| u(t) \|_{H^2} + \| J_u(t) \|_{H^3}).$$
(3.26)

Similarly when we try to obtain

$$\sum_{\substack{\alpha \mid = 3\\|\beta| = 1}} \| (\partial^{\alpha} J^{\beta} F - P_{\alpha\beta})(t) \|_{L^{2}} \le C (1+t)^{-21/20} X_{m}^{2}(t)^{3},$$
(3.27)

we need the bound which is like  $||Q_4(t)||_{W^{3,\infty}}$ . In the same way as (3.2) we get

$$\|Q_4(t)\|_{W^{3,\infty}} \le C \sum_{n=0}^{3} \|u(t)\|_{H^7}^{\frac{n}{5}} \|u(t)\|_{W^{1,\infty}}^{2-\frac{n}{5}} \le C(1+t)^{-21/20} X_m^2(t)^2.$$
(3.28)

Substituting (3.28) into (3.26) we obtain

$$\| Q_3(t) \|_{H^2} \le C(1+t)^{-21/20} X_m^2(t)^3.$$
(3.29)

Similarly we can obtain (3.27). (3.27) – (3.29) shows (3.21). Proof of Lemma 3.4 is finished.  $\Box$ 

Remark 3.1. Let N=2. In general, if m > 3l'/2 + 2,  $l' \in \mathbb{N}$ , then we can obtain

$$|JF(t)||_{H^{I'-1}} + \sum_{\substack{|\alpha|=1'\\|\beta|=1}} ||(\partial^{\alpha}J^{\beta}F - P_{\alpha\beta})(t)||_{L^{2}} \le C(1+t)^{-(1+4\varepsilon_{1})} (||u(t)_{H^{m}} + ||Ju(t)||_{H^{I'}})^{3}$$
(3.30)

for  $u \in C([0, T]; H^m) \cap C([0, T]; H^{\prime,1})$  satisfying

$$\sup_{t \in [0,T]} (\| u(t) \|_{H^m} + \| Ju(t) \|_{H^r}) \le R \text{ with some } R > 0,$$

where  $\varepsilon_1 = \frac{m - 3l'/2 - 2}{8(m-2)} > 0.$ 

### §4. Proof of Theorem 1.1

In this section we prove Theorem 1.1 by the parabolic regularization and the uniform estimates.

At the first step we consider

$$\partial_t u^{\varepsilon} - (\varepsilon + i) \, \Delta \, u^{\varepsilon} = F(u^{\varepsilon}, \, \nabla u^{\varepsilon}) \quad \text{in} \quad (0, \, \infty) \times \mathbb{R}^N, \tag{4.1}$$

$$u^{\varepsilon}(0, x) = u_0(x) \qquad \text{in} \quad \mathbb{R}^N, \tag{4.2}$$

where  $\varepsilon \in (0, 1]$ . Because the parabolic regularization resolve the loss of derivatives, we can easily solve (4.1) - (4.2)

**Lemma 4.1.** Let m be an integer > N/2 + 1. Then for any  $u_0 \in H^m$ , there exists a time  $T_{\varepsilon} = T(\varepsilon, ||u_0||_{H^{\lfloor N/2 \rfloor + 2}}$  such that the initial value problem (4.1) - (4.2) possesses a unique solution  $u^{\varepsilon} \in C([0, T_{\varepsilon}); H^m)$ . Moreover the map  $u_0 \in H^m \mapsto u^{\varepsilon} \in C([0, T_{\varepsilon}); H^m)$  is continuous.

*Proof.* It is easy to verify Lemma 4.1 with (3.2) and (3.4). See e.g., [1] or [2].  $\Box$ 

To get a local solution to (1.1) - (1.2), we obtain the uniform estimates on  $\{u^{\varepsilon}\}_{\varepsilon \in (0,1]}$  by the energy inequality in Lemma 2.4. Let  $l \in \mathbb{N}$  be the same integer as in §2. We put  $m_1 = \lfloor N/2 \rfloor + l + 4$  and let m be an integer  $\geq m_1$ . As we mentioned in Remark 2.1, if  $\|u^{\varepsilon}(t)\|_{W^{1,\infty}} \leq R < +\infty$ , then there exists a constant M = M(R, F) > 0 such that

$$\left|\operatorname{Im}\frac{\partial F}{\partial q_{j}}(u^{\varepsilon}(t), \nabla u^{\varepsilon}(t))\right| \leq C_{R} \sup_{\check{x}, \in \mathbf{R}^{N-1}} \left(\left|u^{\varepsilon}(t, x)\right| + \left|\nabla u^{\varepsilon}(t, x)\right|\right)^{2} \leq \phi_{j}^{\varepsilon}(t, x_{j}),$$
  
$$\phi_{j}^{\varepsilon}(t, x_{j}) = M \sum_{|\alpha| \leq \left[\frac{N-1}{2}\right]+2} \int_{\mathbf{R}^{N-1}} \left|\partial^{\alpha} u^{\varepsilon}(t, x)\right|^{2} d\check{x}_{j}.$$
(4.3)

We define

$$v_{\alpha}^{\varepsilon} = {}^{t} \left( \partial^{\alpha} u^{\varepsilon}, \ \partial^{\alpha} \overline{u^{\varepsilon}} \right), \quad v_{\alpha,0} = {}^{t} \left( \partial^{\alpha} u_{0}, \ \partial^{\alpha} \overline{u_{0}} \right), \quad \text{for} \quad |\alpha| = m,$$

$$b_{11j,\varepsilon}(t, x) = -\frac{\partial F}{\partial q_{j}}(u^{\varepsilon}, \nabla u^{\varepsilon}), \quad b_{12j,\varepsilon}(t, x) = -\frac{\partial F}{\partial \bar{q}_{j}}(u^{\varepsilon}, \nabla u^{\varepsilon}),$$

$$b_{21j,\varepsilon}(t, x) = \overline{\frac{\partial F}{\partial \bar{q}_{j}}(u^{\varepsilon}, \nabla u^{\varepsilon})}, \quad b_{22j,\varepsilon}(t, x) = \overline{\frac{\partial F}{\partial q_{j}}(u^{\varepsilon}, \nabla u^{\varepsilon})},$$

$$b_{\varepsilon}(t, x, \xi) = \sum_{j=1}^{N} \begin{bmatrix} b_{11j,\varepsilon}(t, x) & b_{12j,\varepsilon}(t, x) \\ b_{21j,\varepsilon}(t, x) & b_{22j,\varepsilon}(t, x) \end{bmatrix} \xi_{j},$$

$$b_{\varepsilon}^{\text{diag}}(t, x, \xi) = \sum_{j=1}^{N} \begin{bmatrix} b_{11j,\varepsilon}(t, x) & 0 \\ 0 & b_{22j,\varepsilon}(t, x) \end{bmatrix} \xi_{j},$$

$$K_{\varepsilon}(t) = k_{\varepsilon}(t, x, D), \quad k_{\varepsilon}(t, x, \xi) = \begin{bmatrix} k_{1,\varepsilon}(t, x, \xi) & 0\\ 0 & k_{1,\varepsilon}(t, x, \xi)^{-1} \end{bmatrix}$$
$$k_{1,\varepsilon}(t, x, \xi) = \exp\left(-\sum_{j=1}^{N} \int_{0}^{x_{j}} \phi_{j}^{\varepsilon}(t, s) ds\xi_{j}\langle\xi_{j}\rangle^{-1}\right),$$
$$\Lambda_{\varepsilon}(t) = I + \tilde{\Lambda}_{\varepsilon}(t), \quad \tilde{\Lambda}_{\varepsilon}(t) = \tilde{\lambda}_{\varepsilon}(t, x, D),$$
$$\tilde{\lambda}_{\varepsilon}(t, x, \xi) = \frac{1}{2} \sum_{j=1}^{N} \begin{bmatrix} 0 & b_{12j,\varepsilon}(t, x) \\ -b_{21j,\varepsilon}(t, x) & 0 \end{bmatrix} \xi_{j}\langle\xi\rangle^{-2},$$
$$N_{m}^{\varepsilon}(t) = \sum_{|\alpha|=m} \|K_{\varepsilon}(t) \Lambda_{\varepsilon}(t) v_{\alpha}^{\varepsilon}(t)\| + \|u^{\varepsilon}(t)\|_{H^{m-1}},$$

$$\begin{split} \delta_{m} &= N_{m}^{\varepsilon}(0) = \sum_{|\alpha|=m} \| K_{\varepsilon}(0) \Lambda_{\varepsilon}(0) v_{\alpha,0} \| + \| u_{0} \|_{H^{m-1}} \quad (\text{ind. of } \varepsilon \in (0,1]), \\ f_{\alpha}^{\varepsilon} &= {}^{t} \left( f_{\alpha,1}^{\varepsilon}, f_{\alpha,2}^{\varepsilon} \right), \quad f_{\alpha,1}^{\varepsilon} = \overline{f_{\alpha,2}^{\varepsilon}} \quad \text{for} \quad |\alpha| = m, \\ f_{\alpha,1}^{\varepsilon} &= \partial^{\alpha} F(u^{\varepsilon}, \nabla u^{\varepsilon}) - \sum_{j=1}^{N} \frac{\partial F}{\partial q_{j}}(u^{\varepsilon}, \nabla u^{\varepsilon}) \partial_{j} \partial^{\alpha} u^{\varepsilon} - \sum_{j=1}^{N} \frac{\partial F}{\partial \bar{q}_{j}}(u^{\varepsilon}, \nabla u^{\varepsilon}) \partial_{j} \partial^{\alpha} \bar{u}^{\varepsilon}. \end{split}$$

In the same way as in §2, we define  $B_{b_{\varepsilon}}(t)$ ,  $B_{K_{\varepsilon}}(t)$ ,  $B_{\phi^{\varepsilon}}^{0}(t)$ ,  $B_{\phi^{\varepsilon}}^{1}(t)$  and  $B_{\phi^{\varepsilon}}^{\infty}(t)$ . It is easy to check that there exists a non-decreasing function  $A(\cdot)$  on  $[0, \infty)$  such that

 $B_{b_{\varepsilon}}(t), B_{K_{\varepsilon}}(t), B_{\phi^{\varepsilon}}^{0}(t), B_{\phi^{\varepsilon}}^{1}(t), B_{\phi^{\varepsilon}}^{\infty}(t) \leq A\left( \left\| u^{\varepsilon}(t) \right\|_{H^{m_{1}-1}} \right).$ 

(3.2) - (3.3) implies

$$\|F(u^{\varepsilon}(t), \nabla u^{\varepsilon}(t))\|_{H^{m-1}} + \sum_{|\alpha|=m} \|f^{\varepsilon}_{\alpha}(t)\| \leq A(\|u^{\varepsilon}(t)\|_{H^{m-1}}) \|u^{\varepsilon}(t)\|_{H^{m}}$$

Let  $T_{\varepsilon}^*$  be a time defined by

$$T_{\varepsilon}^* = \sup \left\{ T > 0 | N_{m_1}^{\varepsilon}(t) < 2\delta_{m_1}, \quad 0 \le t < T \right\}.$$

Lemma 4.1 ensures  $T_{\varepsilon}^* > 0$ . In view of the Sobolev embedding, there exists a constant  $R = R(\delta_{m_1}) > 0$  such that  $\| u^{\varepsilon}(t) \|_{W^{1,\infty}} \leq R$  for  $t \in [0, T_{\varepsilon}^*]$  and  $\varepsilon \in (0,1]$ . Moreover there exists a constant  $C(\delta_{m_1}) > 0$  such that

$$B_{b_{\varepsilon}}(t), B_{K_{\varepsilon}}(t), B_{\phi^{\varepsilon}}^{0}(t), B_{\phi^{\varepsilon}}^{1}(t), B_{\phi^{\varepsilon}}^{\infty}(t) \leq C(\delta_{m_{1}}),$$

$$C(\delta_{m_{1}})^{-1} N_{m}^{\varepsilon}(t) \leq \| u^{\varepsilon}(t) \|_{H^{m}} \leq C(\delta_{m_{1}}) N_{m}^{\varepsilon}(t),$$

$$\| F(u^{\varepsilon}(t), \nabla u^{\varepsilon}(t)) \|_{H^{m-1}} + \sum_{|\alpha|=m} \| K_{\varepsilon}(t) \Lambda_{\varepsilon}(t) f_{\alpha}^{\varepsilon}(t) \| \leq C(\delta_{m_{1}}) N_{m}^{\varepsilon}(t) \qquad (4.4)$$

for  $t \in [0, T_{\varepsilon}^*]$  and  $\varepsilon \in (0, 1]$ .  $v_{\alpha}^{\varepsilon}$  satisfies

$$\left( I\partial_t + \varepsilon I |D|^2 + i(a(D) + b_{\varepsilon}(t, x, D)) \right) v_{\alpha}^{\varepsilon} = f_{\alpha}^{\varepsilon}$$
$$v_{\alpha}^{\varepsilon}(0, x) = v_{\alpha,0}(x) .$$

The local wellposedness for (4.1) - (4.2) ensures the validity of the energy estimates. Here we note that

$$\varepsilon \Lambda_{\varepsilon}(t) I | D|^{2} = \varepsilon I | D|^{2} \Lambda_{\varepsilon}(t) + \varepsilon R_{2,\varepsilon}(t),$$
$$R_{2,\varepsilon}(t) = \tilde{\Lambda}_{\varepsilon}(t) | D|^{2} - | D|^{2} \tilde{\Lambda}_{\varepsilon}(t), \quad || R_{2,\varepsilon}(t) ||_{\mathscr{L}(L^{2})^{2}} \leq C(\delta_{m_{1}}) \text{ for } t \in [0, T_{\varepsilon}^{*}].$$

(2.6) - (2.7) implies

$$(I\partial_{t} + \varepsilon I \mid D \mid^{2} + ia(D) + q_{\varepsilon}(t, x, D)) K_{\varepsilon}(t) \Lambda_{\varepsilon}(t) v_{\alpha}^{\varepsilon} + R_{3,\varepsilon}(t) v_{\alpha}^{\varepsilon} = K_{\varepsilon}(t) \Lambda_{\varepsilon}(t) f_{\alpha}^{\varepsilon},$$

$$q_{\varepsilon}(t, x, D) = 2(I + i\varepsilon \tilde{I}) \sum_{j=1}^{N} \phi_{j}^{\varepsilon}(t, x_{j}) D_{j}^{2} \langle D_{j} \rangle^{-1} + b_{\varepsilon}^{\text{diag}}(t, x, D),$$

$$R_{3,\varepsilon} = R_{1,\varepsilon}(t) + \varepsilon K_{\varepsilon}(t) R_{2,\varepsilon}(t), \quad ||R_{3,\varepsilon}(t)||_{\mathscr{L}((L^{2})^{2})} \leq C(\delta_{m_{1}}) \text{ for } t \in [0, T_{\varepsilon}^{*}],$$

where  $R_{1,\varepsilon}(t)$  corresponds to  $R_1(t)$  (see §2) and  $\tilde{I}$  is a 2×2 diagonal matrix of (1,-1). Noting (4.3), in the same manner as (2.10) we get

$$\frac{d}{dt} \| K_{\varepsilon}(t) \Lambda_{\varepsilon}(t) v_{\alpha}^{\varepsilon}(t) \| \leq C(\delta_{m_1}) N_{m}^{\varepsilon}(t) + \| K_{\varepsilon}(t) \Lambda_{\varepsilon}(t) f_{\alpha}^{\varepsilon}(t) \|.$$
(4.5)

On the other hand we have

$$\frac{d}{dt} \| u^{\varepsilon}(t) \|_{H^{m-1}} \leq \| F(u^{\varepsilon}(t), \nabla u^{\varepsilon}(t)) \|_{H^{m-1}}.$$

$$(4.6)$$

Combining (4.4), (4.5) and (4.6) we obtain

$$\frac{d}{dt} N_m^{\varepsilon}(t) \le C(\delta_{m_1}) N_m^{\varepsilon}(t), \quad \text{for } t \in [0, T_{\varepsilon}^*].$$

The Gronwall inequality yields

$$N_m^{\varepsilon}(t) \le \delta_m \exp\left(C(\delta_{m_1})t\right) \text{ for } t \in [0, T_{\varepsilon}^*].$$

$$(4.7)$$

If we put  $m = m_1$  and  $t = T_{\varepsilon}^*$  in (4.7), then we have

$$T_{\varepsilon}^* \geq T \equiv (\log 2) C(\delta_{m_1})^{-1} > 0.$$

Hence  $\{u^{\varepsilon}\}_{\varepsilon \in (0,1]}$  is bounded in  $L^{\infty}(0, T; H^m)$ . Then the standard compactness argument implies that there exists a solution  $u \in L^{\infty}(0, T; H^m)$  to (1.1) - (1.2) (see [1] for instance). The uniqueness and the continuity in the time variable are proved by the same energy method. This completes the proof of Theorem 1.1.

# **§5.** Proof of Theorem 1.2

In this section we prove Theorem 1.2. In view of Theorem 1.1, we have only to obtain the *a priori* estimates on  $||u(t)||_{H^{m_1}}$ . Let *l* be the same integer as in §2. We take  $m_2$  as  $m_2 = [(N+1)/2] + l+5 \ge m_1+1$ . Then it is sufficient to get the *a* 

priori estimates on  $|| u(t) ||_{H^{m_2}}$ . Since we assume  $u_0 \in H^{m_2+2}$ , Theorem 1.1 and Lemma 2.4 ensure the validity of the energy estimates in  $H^{m_2}$ .

Let u be a solution to (1.1) - (1.2) satisfying

$$u \in \bigcap_{j=0}^{2} C([0, T]; H^{m-2j,j}), \sup_{t \in [0,T]} \| u(t) \|_{W^{1,\infty}} \leq R_{0}$$

with some T,  $R_0 > 0$  and some  $m \in \mathbb{N} \ge m_2 + 2$ . The local existence in this weighted Sobolev space is proved by the same method proving Theorem 1.1 or by [2]. To carry out the energy estimates, we introduce some notations

$$\begin{split} b_{11j}^{1}(t, x) &= -\frac{\partial F}{\partial q_{j}}(u, \nabla u), \quad b_{12j}^{1}(t, x) = -\frac{\partial F}{\partial \bar{q}_{j}}(u, \nabla u), \\ b_{21j}^{1}(t, x) &= \overline{\partial F}{\partial \bar{q}_{j}}(u, \nabla u), \quad b_{22j}^{1}(t, x) = \overline{\partial F}{\partial q_{j}}(u, \nabla u), \\ b_{11j}^{2}(t, x) &= -G_{j}(u, \nabla u), \quad b_{12j}^{2}(t, x) = -G'_{j}(u, \nabla u), \\ b_{21j}^{2}(t, x) &= -\overline{G'_{j}(u, \nabla u)}, \quad b_{22j}^{2}(t, x) = \overline{G_{j}(u, \nabla u)}, \quad j = 1, \cdots, N, \\ b_{21j}^{n}(t, x, \xi) &= \sum_{j=1}^{N} \begin{bmatrix} b_{11j}^{n}(t, x) & b_{12j}^{n}(t, x) \\ b_{21j}^{n}(t, x) &= b_{22j}^{n}(t, x) \end{bmatrix} \xi_{j}, \quad n = 1, 2. \end{split}$$

In the same way as in §2, we define  $B_{b^n}(t)$ , n=1, 2 and we put  $B_b(t) = B_{b^1}(t) + B_{b^2}(t)$ . By the Gagliardo-Nirenberg inequality (the interpolation between  $W^{1,\infty}$  and  $H^{m_2-1}$  for  $W^{l+3,\infty}$ ) and (3.14), we have

$$B_{b}(t) \leq C_{R_{0}}(1+t)^{-(1+\varepsilon)} X_{m_{2}-1}^{N}(t)^{2} \text{ for } t \in [0, T], \qquad (5.1)$$

$$\varepsilon = \frac{7}{4} \frac{m_{2} - N/2 - 2l/7 - 4}{m_{2} - N/2 - 4} > 0.$$

Using (3.6), in the same way as (4.3), we have

 $|\operatorname{Im} b_{hhj}^{n}(t, x)| \le \phi_{j}(t, x_{j}), \text{ for } (t, x) \in [0, T] \times \mathbb{R}^{N}, n, h=1, 2, j=1, \cdots, N, (5.2)$ 

$$\phi_{j}(t, x_{j}) = M(1+t)^{-3/2} \sum_{\substack{|\alpha| \leq \left[\frac{N+1}{2}\right]+1\\|\beta| \leq 1}} \int_{\mathbf{R}^{N-1}} |\partial^{\alpha} J^{\beta} u(t, x)|^{2} d\check{x}_{j}, j=1, \cdots, N,$$

where  $M = M(R_0, F) > 0$  is a sufficiently large constant. We introduce the pseudodifferential operators defined as follows.

$$K(t) = k(t, x, D), \quad k(t, x, \xi) = \begin{bmatrix} k_1(t, x, \xi) & 0\\ 0 & k_1(t, x, \xi)^{-1} \end{bmatrix},$$
  
$$k_1(t, x, \xi) = \exp\left(-\sum_{j=1}^N \int_0^{x_j} \phi_j(t, s) \, ds\xi_j \langle \xi_j \rangle^{-1}\right),$$
  
$$\Lambda_n(t) = I + \tilde{\Lambda}_n(t), \quad \tilde{\Lambda}_n(t) = \tilde{\lambda}_n(t, x, D),$$
  
$$\tilde{\lambda}_n(t, x, \xi) = \frac{1}{2} \sum_{j=1}^N \begin{bmatrix} 0 & b_{12j}^n(t, x)\\ - b_{21j}^n(t, x) & 0 \end{bmatrix} \xi_j \langle \xi \rangle^{-2}, \quad n = 1, 2.$$

We also define  $B_K(t)$ ,  $B^0_{\phi}(t)$ ,  $B^1_{\phi}(t)$  and  $B^{\infty}_{\phi}(t)$ . The simple calculation yields

$$B_{K}(t), B_{\phi}^{0}(t) \leq A(X_{m_{2}-1}^{N}(t)), \qquad (5.3)$$

$$B^{1}_{\phi}(t), B^{\infty}_{\phi}(t) \le C_{R_{0}}(1+t)^{-3/2}X^{N}_{m_{2}-1}(t)^{2},$$
 (5.4)

where  $A(\cdot)$  is a non-decreasing function on  $[0, \infty)$  depending on  $R_0$ . We put

$$v_{\alpha} = {}^{t} (\partial^{\alpha} u, \partial^{\alpha} \bar{u}), \qquad v_{\alpha,0} = {}^{t} (\partial^{\alpha} u_{0}, \partial^{\alpha} \overline{u_{0}}),$$
$$f_{\alpha} = {}^{t} (f_{\alpha,1}, f_{\alpha,2}), \qquad f_{\alpha,1} = \overline{f_{\alpha,2}},$$
$$f_{\alpha,1} = \partial^{\alpha} F - P_{\alpha}, \qquad \text{for } |\alpha| = m_{2},$$

and

$$v_{\alpha\beta} = {}^{t} (\partial^{\alpha} J^{\beta} u, \overline{\partial^{\alpha} J^{\beta} u}), \qquad v_{\alpha\beta,0} = v_{\alpha\beta} (0) = {}^{t} (\partial^{\alpha} (x^{\beta} u_{0}), \overline{\partial^{\alpha} (x^{\beta} u_{0})}),$$
  
$$f_{\alpha\beta} = {}^{t} (f_{\alpha\beta,1}, f_{\alpha\beta,2}), \qquad f_{\alpha\beta,1} = \overline{f_{\alpha\beta,2}}$$
  
$$f_{\alpha\beta,1} = \partial^{\alpha} J^{\beta} F - P_{\alpha\beta}, \qquad \text{for} |\alpha + 2\beta| = m_{2}, |\beta| = 1, 2.$$

We evaluate  $Y_{m_2}^N(t)$  which is defined by

$$Y_{m_{2}}^{N}(t) = X_{m_{2}-1}^{N}(t) + \sum_{\substack{|\alpha|=m_{2}\\|\alpha|=m_{2}}} \|K(t)\Lambda_{1}(t)v_{\alpha}(t)\| + \sum_{\substack{|\alpha|=m_{2}-4\\|\beta|=1}} \|K(t)\Lambda_{2}(t)v_{\alpha\beta}(t)\| + (1+t)^{-1/4}\sum_{\substack{|\alpha|=m_{2}-4\\|\beta|=2}} \|K(t)\Psi_{2}(t)v_{\alpha\beta}(t)\| + (1+t)^{-1/4$$

We suppose that there exists a constant R > 0 such that

$$\sup_{t\in[0,T]}Y_{m_2}^N(t)\leq R$$

In view of (2.4), (2.5), (5.1), (5.3) and (5.4), we have

$$C_{R}^{-1} Y_{m_{2}}^{N}(t) \leq X_{m_{2}}^{N}(t) \leq C_{R} Y_{m_{2}}^{N}(t), \quad Y_{m_{2}}^{N}(0) \leq C_{R} \delta,$$
(5.5)

with some constant  $C_R > 0$ . Using (3.17), (3.18) and (3.19) and (5.5) we get

$$\|F(t)\|_{H^{m_{2}-1}} + \sum_{|\alpha|=m_{2}} \|K(t)\Lambda_{1}(t)f_{\alpha}(t)\| \le C_{R}(1+t)^{-11/4}R^{3},$$
(5.6)

$$\|JF(t)\|_{H^{m_{2}-3}} + \sum_{|\alpha|=m_{2}-2} \|K(t)\Lambda_{2}(t)f_{\alpha\beta}(t)\| \le C_{R}(1+t)^{-7/4}R^{3},$$
(5.7)

$$\|J^{2}F(t)\|_{H^{m_{2}-5}} + \sum_{\substack{|\alpha|=m_{2}-4\\|\beta|=2}}^{|\beta|=1} \|K(t)\Lambda_{2}(t)f_{\alpha\beta}(t)\| \le C_{R}(1+t)^{-3/4}R^{3}.$$
(5.8)

With (5.1), (5.3) and (5.4) we have

$$(B_{\phi}(t) + B^{1}_{\phi}(t) + B^{\infty}_{\phi}(t)) B_{\text{etc}}(t) \le C_{\mathcal{R}}(1+t)^{-(1+\varepsilon)}R^{2}.$$
(5.9)

 $v_{\alpha}$  and  $v_{\alpha\beta}$  satisfy

$$\left( I\partial_t + i(a(D) + b^1(t, x, D)) \right) v_{\alpha} = f_{\alpha},$$
$$\left( I\partial_t + i(a(D) + b^2(t, x, D)) \right) v_{\alpha\beta} = f_{\alpha\beta},$$

respectively. Using (2.10), (5.2), (5.6), (5.7), (5.8) and (5.9), we obtain

$$\frac{d}{dt} \sum_{|\alpha|=m_2} \| K(t) \Lambda_1(t) v_{\alpha}(t) \| \le C_R (1+t)^{-(1+\varepsilon)} R^3,$$
  
$$\frac{d}{dt} \sum_{\substack{|\alpha|=m_2-2\\|\beta|=1}} \| K(t) \Lambda_2(t) v_{\alpha\beta}(t) \| \le C_R (1+t)^{-(1+\varepsilon)} R^3,$$
  
$$\frac{d}{dt} \sum_{\substack{|\alpha|=m_2-4\\|\beta|=2}} \| K(t) \Lambda_2(t) v_{\alpha\beta}(t) \| \le C_R (1+t)^{-3/4} R^3.$$

The integration on [0, t] implies

$$\sum_{|\alpha|=m_{2}} \| K(t) \Lambda_{1}(t) v_{\alpha}(t) \| + \sum_{\substack{|\alpha|=m_{2}-2\\|\beta|=1}} \| K(t) \Lambda_{2}(t) v_{\alpha\beta}(t) \|$$
  
+  $(1+t)^{-1/4} \sum_{\substack{|\alpha|=m_{2}-4\\|\beta|=2}} \| K(t) \Lambda_{2}(t) v_{\alpha\beta}(t) \| \le C_{R} (\delta + R^{3}).$  (5.10)

Noting  $[J, \partial_t - i\Delta] = 0$ , we have

$$(\partial_t - i\Delta) \partial^{\alpha} J^{\beta} u = \partial^{\alpha} J^{\beta} F$$
, with  $|\alpha + 2\beta| \le m_2 - 1$ ,  $|\beta| \le 2$ .

Making use of (5.6), (5.7) and (5.8) we obtain

$$X_{m_2-1}^N(t) \le C_R(\delta + R^3). \tag{5.11}$$

Combining (5.10) and (5.11) we get

$$\sup_{t\in[0,T]}Y_{m_2}^N(t)\leq C_R(\delta+R^3).$$

Then there exist constants  $R_1 > 0$  and  $C_{R_1} > 0$  which are independent of T > 0, such that

$$\sup_{t \in [0,T]} Y_{m_2}^N(t) \le C_{R_1}(\delta + R^3), \quad \text{if} \quad R \le R_1.$$

If we choose  $R_1$  as  $C_{R_1}R_1^3 \le R_1/4$  at the beginning, then we have

$$\sup_{t \in [0,T]} Y_{m_2}^N(t) \le R/2 \quad \text{if} \quad R \le R_1$$

provided that  $\delta$  is sufficiently small. This completes the proof of Theorem 1.2.

# §6. Proof of Theorem 1.3

Finally we prove Theorem 1.3. The outline of its proof is basically the same as that of Theorem 1.2. Let *l* be the same integer as in §2. We take  $m_3$  as  $m_3 = [(3l+1)/2] + 7 \ge m_1 + 1$ . We obtain the *a priori* estimates in  $H^{m_3} \cap H^{l+3,1}$ . Let *m* be an integer  $\ge m_3 + 2$  and let *u* be a solution to (1.1) - (1.2) satisfying

$$u \in \bigcap_{j=0}^{2} C([0, T]; H^{m-2j,j}).$$

We define  $\phi_j(t, x_j)$  by

$$\phi_{j}(t, x_{j}) = M(1+t)^{-1} \sum_{\substack{|\alpha| \leq 1 \\ |\beta| \leq 1}} \int_{\mathbf{R}} |\partial^{\alpha} J^{\beta} u(t, x)|^{2} d\check{x}_{j}, \quad j=1, 2,$$

with some large constant M > 0. We introduce K(t),  $\Lambda_n(t)$ ,  $b^n(t, x, \xi)$ , n=1, 2,  $B_K(t)$ ,  $B_b(t)$ ,  $B_\phi^0(t)$ ,  $B_\phi^1(t)$  and  $B_\phi^\infty(t)$  in the same manner as in §5. We put

$$Z(t) = Z_{1}(t) + (1+t)^{-\varepsilon}Z_{2}(t),$$
  

$$Z_{1}(t) = || u(t) ||_{H^{m_{3}-1}} + || Ju(t) ||_{H^{l+2}},$$
  

$$Z_{2}(t) = \sum_{|\alpha|=m_{3}} || K(t) \Lambda_{1}(t) v_{\alpha}(t) || + \sum_{\substack{|\alpha|=l+3\\|\beta|=1}} || K(t) \Lambda_{2}(t) v_{\alpha\beta}(t) ||,$$
  

$$\varepsilon = \frac{m_{3} - (3l+1)/2 - 6}{8(m_{3}-2)} > 0.$$

We suppose that there exists a constant R > 0 such that

$$\sup_{t\in[0,T]}Z(t)\leq R$$

Then we have

 $|\operatorname{Im} b_{hhj}^{n}(t, x)| \le \phi_{j}(t, x_{j}), \text{ for } (t, x) \in [0, T] \times \mathbb{R}^{N}, n, h, j=1, 2, (6.1)$ 

 $B_{\mathbf{K}}(t), \ B_{\phi}^{0}(t) \leq C_{\mathbf{R}}, \ B_{\phi}^{1}(t), \ B_{\phi}^{\infty}(t) \leq C_{\mathbf{R}}(1+t)^{-1}R^{2}, \ B_{b}(t) \leq C_{\mathbf{R}}(1+t)^{-(1+2\varepsilon)}R^{2},$ (6.2)

$$(B_b(t) + B^1_{\phi}(t) + B^{\infty}_{\phi}(t)) B_{\text{etc}}(t) \le C_R (1+t)^{-1} R^2,$$
(6.3)

$$\|F(t)\|_{H^{m_{3}-1}} + \sum_{\substack{|\alpha|=m_{3}\\|\alpha|=m_{3}}} \|K(t)\Lambda_{1}(t)f_{\alpha}(t)\|$$
  
 
$$+ \|JF(t)\|_{H^{l+2}} + \sum_{\substack{|\alpha|=l+3\\|\beta|=1}} \|K(t)\Lambda_{2}(t)f_{\alpha\beta}(t)\| \le C_{R}(1+t)^{-(1+\varepsilon)}R^{3}.$$
 (6.4)

Here we used (3.30) to get the bound of  $B_b(t)$ . Using (2.10) and (6.1)  $\sim$  (6.4), we obtain

$$\sup_{t \in [0,T]} Z(t) \leq C_R \left(\delta + R^3\right).$$

In the same way as the proof of Theorem 1.2, we can obtain the *a priori* estimates. This completes the proof of Theorem 1.3.
